DORS provides Transition Services for Students with Disabilities.

Transition Services are activities that prepare students with disabilities to move from school to post-school life.

DORS provides these services in close partnership with the student, family, school staff, approved community rehabilitation providers (CRPs), and other important people in the student's life.

# SERVICES FOR STUDENTS

## A Student with a Disability is someone who:

- \* Is enrolled in a secondary school (including home school or other alternative secondary education program), post-secondary education program, or other recognized educational program, and has not graduated or withdrawn.
- \* Is at least 14 years old but less than age 22.
- \* And has a disability documented with an Individualized Education Program (IEP), 504 plan, or medical records.

DORS offers **two sets of services** for Students with Disabilities.

## PRE-EMPLOYMENT TRANSITION SERVICES

(Students ages 14 to 21)

**Pre-Employment Transition Services (Pre-ETS)** provide Students with Disabilities who qualify with the opportunity to experience and explore the world of work.

The five specific **Pre-ETS** are:

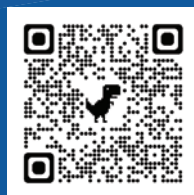
- \* Job Exploration Counseling
- \* Self-Advocacy Instruction
- \* Workplace Readiness Training
- \* Post-Secondary Education Opportunities Counseling
- \* Work-Based Learning Experiences

## REQUEST DORS SERVICES

Go to [dors.maryland.gov](https://dors.maryland.gov) and select **Request DORS Services**. You will be contacted to set up an intake meeting where a DORS counselor will gather and provide information regarding qualification for Pre-ETS or eligibility for Student Employment Services.

**This form can be completed by anyone** – the job seeker or student themselves, a parent or family member, a medical provider, a teacher, etc.

## STUDENT EMPLOYMENT SERVICES

(Students ages 14 to 21)

Student Employment Services are for students with disabilities who would like to receive Pre-ETS and also obtain or prepare for meaningful employment and a successful career. A broad range of vocational rehabilitation services may be available to these students.

### Student Employment Services may include:

- \* Career counseling and decision making based on the student's interests, abilities, and goals.
- \* Skills and job training to prepare for employment.
- \* Disability-related skills training.
- \* Post-secondary education.
- \* Job search and job placement services.
- \* Job coaching and supported employment services.
- \* Assistive technology solutions for disability-related needs.
- \* Pre-Employment Transition Services (Pre-ETS).

**Unlike Pre-ETS, Student Employment Services are subject to eligibility requirements.**  
*Your DORS counselor will provide more information.*

### Eligibility for Student Employment Services

- \* Federal law requires that DORS serve people with the most significant disabilities first.
- \* Due to resource limitations, eligible individuals may be placed on the waiting list for services.
- \* Supplemental Security Income (SSI) recipients are presumed eligible for services, but may be placed on the waiting list.

**Your DORS counselor will provide more information.**

**There may be a waiting list for Student Employment Services.**

Students who are found eligible for Student Employment Services but are placed on the DORS Waiting List may still receive Pre-ETS.
